WHEREFORE, Petitioner prays that the clerk of this Court send by certified mail a copy of this petition, together with the order setting hearing, to the attorney for the State and that on final hearing the Court grant Petitioner an occupational driver's license for essential need and order the Texas Department of Public Safety to issue an occupation license to Petitioner and for such other and further relief as the Petitioner may show entitlement to and the Court deem proper.
